Executive Summary

FATA University was established after the promulgation of the FATA University Regulations-2013. Prof. Dr. Mohammad Tahir Shah was appointed as the first Vice Chancellor of the university. The Government of Pakistan has allocated Rs. 4.7 billion for the phase wise establishment of full-fledged FATA University. In the first phase, the CDWP has approved a PC-1 amounting to Rs. 1.593 billion for five years in April 2016 and an amount of Rs. 250 million was released by HEC for the year 2015-16 in this regard. The PC-1 project includes Infrastructure Development, Human Resource Development and Procurement of equipment and furniture etc. Another PC-1 amounting to Rs. 4.008 million for the "Establishment of Project Management Unit (PMU)" was approved by the FDWP in April 2016. The PMU has been established in a portion of Government Degree College (GDC), Darra Adam Khel, FR Kohat, which is responsible for the infrastructure development of the university on already purchased 468 Kanal piece of land contiguous to the college building.

The first ever academic activity of FATA University started in October 2016 after shifting to the PMU in GDC, Darra Adam Khel, NMD Kohat. Before launching admissions in BS 4-years' degree program in four Disciplines i.e., Management Sciences, Political Science, Sociology and Mathematics in September 2016. The appointment of faculty and staff was completed through merit and transparency based process of selection. Three more disciplines i.e., Computer science, Geology and English were added in October 2017. To run these departments the appointment of the new faculty and staff and the admissions of students were completed before the start of the Fall Semester in October 2017. The existing building does not suffice the requirement of the university, therefore, the construction of its own infrastructure on the acquired piece of land has been expedited.

Being a newly established university, the management of FATA University has been facing huge challenges but due to its continuous efforts, devotion and dedication most of the hurdles have been taken care of and numerous achievements have been made. These achievements are briefly discussed as follows:(1) two

PC-1 schemes worth Rs. 1.593 billion and Rs. 40.008 million have been prepared which have already been approved, 2)a renovation work in the portion of Degree College was completed in shortest possible time before shifting, (3) a versatile website of FATA University was developed for displaying the regular information, (4) the merit based appointment of faculty and staff has been done through open competition, (5) admissions in seven disciplines have been carried out so far, (6) four academic years are close towards its completion (7) the Selection Board and various other committees have been constituted for the smooth running of the affairs of the university,(8) the statutory bodies such as Academic Council, Finance and Planning Committee, Syndicate and Senate have been constituted and several meetings of these bodies have been called so far,(9) twenty overseas scholarships as per provision of PC-1 were advertised and Eighteen qualified candidates have been awarded overseas scholarship for carrying out Ph.D. studies in the universities abroad, six among these candidates have already left abroad for higher studies . The remaining scholars have already been selected and they are in a process of going abroad(10) a consultant firm was hired for the preparation of Master Plan and Detailed Designing, (11) the Master Plan and Detailed Design has been approved by the HEC Technical Review Committee and the prequalification of the construction firms has already been done, (12) the whole civil work has been divided into seven packages, (13) the work orders to the prequalified firm for all the seven packages have been issued, (12) the construction work on the infrastructure of all the seven packages is underway with great acceleration, (13) a separate electric feeder for FATA University has been approved by TESCO and the installation work has been completed and the University is now having independent uninterrupted supply of electricity, (14) the internet and telephone facilities have been provided through fiber optics, (15) various types of students' societies have been constituted and these societies are involved in arranging workshops / seminars and other extracurricular activities in FATA University. These societies have already arranged several workshops, seminars, and Book fairs for enhancing the intellectual capabilities of the students.

About FATA University

he establishment of an institution of higher learning in the Federally Administered Tribal Areas (FATA) remained the long-standing demand of the people of this region. The plan for establishing a University of international standard in FATA was finally conceived when the former Prime Minister of Pakistan, Mr. Yousaf Raza Gillani announced its establishment during a meeting with MNAs from FATA on January 16, 2009. However, the project got delayed due to a number of reasons until the former President, Mr. Asif Ali Zardari, approved the FATA University Regulations in May 2013. Afterwards, Government of Pakistan included a project titled "Establishment of FATA University" in PSDP (HEC) 2015-16 at an estimated cost of Rs. 4.7 billion with the allocation of Rs.250.00 million for the FY 2015-16.

In the meanwhile, Mr. Mehtab Ahmad Khan Abbasi, Governor and chancellor of FATA University took keen interest and expedited the process of the establishment of FATA University in the erstwhile FATA region. In this regard, FATA Secretariat and Ministry of SAFRON started the process of appointment of the Vice Chancellor. The search committee constituted for the purpose interviewed the shortlisted candidates and recommended a list of three names for the consideration of the then Chancellor/Governor KP, Mr. Mehtab Ahmad Khan Abbasi. The Notification for the appointment of Prof. Dr. Mohammad Tahir Shah (T.I.) as the first Vice Chancellor of the University, after the approval of the Chancellor was issued vide FATA Secretariat Notification No. PS/E/100-96 (Vol-10) / 412-24, dated 13-01-2016 and the newly appointed Vice Chancellor assumed the charge of his office on January 18,2016.

Soon after assuming charge, the Vice Chancellor started his activities in his camp office established in the National Centre of Excellence in Geology (NCEG), University of Peshawar where he was the Director before starting the new assignment. The faculty and staff of the NCEG extended full support in the routine matters to the VC and also the facilities of the NCEG were used in the initial stages which is highly appreciated. The Vice Chancellor started work on the preparation of the two PC-1s for obtaining funding for the smooth running of the affairs of the university. A PC-1 titled "Establishment of FATA University" was approved by the CDWP in April 2016 at a cost of Rs. 1.593 billion. This project includes Infrastructure Development, Human Resource Development and Procurement of equipment, furniture etc. Another project titled "Establishment of Project Management Unit (PMU)" for FATA University was approved by FDWP at a cost of Rs. 31.488 million. However, the scheme was revised and approved at a revised cost of Rs. 40.008 million by the FDWP in its meeting held on February 23, 2016. Accordingly, the PMU was established in a portion of Government Degree College, Darra Adam Khel which is responsible for the infrastructure development of the university

FATA University was inaugurated by the then Governor Khyber Pakhtunkhwa, Engr. Iqbal Zafar Jhagra during inauguration ceremony on December 5, 2016. In this way the university development process got momentum and in a very short span of time the university started its academic activities. By that time four to six semesters in the BS programs of various disciplines had been completed. Initially, the university launched four years bachelor programs in Management Sciences, Political Science, Sociology, and Mathematics while three more disciplines such as Computer Science, Geology, and English were started in September, 2017.

The full-fledged university will be completed in various phases. The FATA Secretariat, in consultation with the parliamentarians of FATA, purchased land measuring 266 kanals at Akhurwal, Darra Adam Khel, NMD Kohat through a development project approved by FDWP. The Governor Khyber Pakhtunkhwa, Engr. Iqbal Zafar Jhagra, during his visit to the university directed for the purchase of additional land in view of the university's future requirements. The scheme for the procurement of 202 kanal, contiguous to the already purchased land was approved as a non-ADP scheme at FDWP level at a total cost of Rs.141.4 million. The demarcation of 468 kanal land has been made and consequently the purchase has been finalized. The infrastructure development (i.e., boundary wall with main gate, 50000 overhead water tank, tube wells, academic blocks, administration block, main library, community centre, gymnasium, students & faculty hostels, Family Housing and external work including roads, pathways, sewerage etc.) on the campus is in progress.

- To develop world class facilities to support faculty and student research and their creative endeavors




Student Enrollments

However, in near future after the completion of ongoing construction and the return of some of the scholars sent abroad, the process for launching of post graduate degree programs will soon be started.

Academic achievements

Courses offered

During Fall and Spring Semesters of Session 2020-2021, 487 credit hours courses were offered in seven disciplines. These courses were taught by both regular and visiting faculty members. The titles and contents of the courses offered in each disciplines, during each semester, are already approved by the HEC Curriculum Committees and the Syndicate of the University. Pre-Service and in-service professional development programs

The faculty members of the FATA University are encouraged to improve their qualification by various possible means. In this regard the lecturers of the university are already enrolled in the Ph.D Programs. Besides, routine course work the trainings, workshops and seminars have been arranged to provide platform not only to faculty but also to the students for their capacity building in different areas of education.







Basic enrolment

The current total enrolment of FATA University is 723 students in seven disciplines. This includes 139 in Managemnet Sciences, 100 in Political Science, 115 in Sociology, 58 in Mathematics, 111 in Computer Science, 93 in Geology and 107 in English. As of its infancy stage and the non availability of basic facilities, the enrollement is relatively low but it is hoped that it will increase with the passage of time. 

Governance

FATA University is being run under the FATA University Regulations 2013. Accordingly, the statutory bodies such as Senate, Syndicate, Academic Council and Board of Faculty etc. have been constituted for running the affairs of the university. The Selection Board, Selection Committee, Procurement / Purchase Committee, Project Implementation Committee and other committees have already been constituted and are functional.

Office of Resource Generation/Development

Initiatives and implementation

The faculty and staff of the University is determined to take various steps for the up-gradation of the University. Various initiatives have been taken in this regard but due to the limited space available in the college building the implementation of these initiatives is not fully achieved.

Future plans

The infrastructure of FATA University and the Administrative and Academic requirements in more than seven faculties as per FATA University Regulations 2013 will be completed in different phases. In the first phase a limited infrastructure and Academic programs will be completed within 5 years with the estimated cost of about Rs. 1.6 billion under the present PC-1 scheme. However, the completion of Academic Programs under the FATA University Regulations 2013, will take place under different phases in future with the estimated cost of more than 4.7 billion.

Under the approved PC-1 Scheme, the following activities will be accomplished during the next 5 years:

• Establishment of Academic, Administrative, Residential and Common facilities at a covered area of 240,225 square feet.

- 20 foreign Ph.D. scholarships will be given to newly appointed faculty for completing their higher studies from the technologically advanced countries.
- Purchase of teaching lab equipment, chemicals, consumables and furniture fixture etc. for Computer Science & IT, Earth Sciences, Electronics, and Chemistry laboratories.
- Hiring of faculty and staff for smooth running of the affairs of the university.
- Purchase of the vehicles for official transportation.
- Affiliation of Colleges and establishment of campuses in the newly merged districts.

Academic Programs

The FATA University has started various disciplines in the faculties of

- 1) Faculty of Management and Social Science.
- 2) Faculty of Physical and Numerical Sciences.
- 3) Faculty of Languages and Literature.

Emerging discipline in the following faculties have been started.

- Faculty of Management and Social Science
- Faculty of Physical and Numerical Sciences
- Faculty of Languages and Literature
- Faculty of Chemical Sciences
- Faculty of Life Sciences
- Faculty of Religious and Legal Studies

Presently, the FATA University is offering the BS 4 years' program in seven disciplines. Due to limited space available in the present college building, no further disciplines can be opened till the completion of its own infrastructure. However, after one year, when the infrastructure will be completed, the MS and Ph.D programs will also be started. It is also planned that

highly qualified faculty will be hired so that the research capability of the university can be increased. Twenty faculty members will be sent for Ph.D studies under the Overseas Ph.D. Scholarship program as per PC-1 provision. One year Diploma and Certificates program will also be started to enhance the professional capabilities of the professionals, especially in technical field.

Laboratory Development

The FATA University intends to establish state of the art laboratories in all the Science disciplines which can be equipped with sophisticated instruments where the data can be produced for carrying out research of international repute. Presently a Computer Laboratory has been established which is catering the needs of BS students.

Human Resources

The management of the FATA University has started hiring of best of the best highly qualified faculty and in future. The same procedure will be adopted to hire the best faculty. Twenty faculty members will be sent abroad for higher studies under the Overseas Ph.D. Scholarship Programs in various emerging disciplines. The refresher courses and certificate programs will be initiated to improve the skills of the faculty and administrative staff.

Health Centre/Medical Facilities

At the moment, there is no any medical facility available in the FATA University. However, within a couple of years the Medical Centre will be established in the university as per PC-1 provision. This Centre will then be able to provide all sorts of medical facilities to the faculty, staff and students of the university.


Master Plan and Detail designing of the Infrastructure of FATA University
