MINUTES OF 27th SYNDICATE MEETING HELD ON JANUARY 7, 2026

The meeting commenced with the recitation of a few verses from the Holy Quran, followed by the introduction of the members. Prof. Dr. Mohsan Nawaz, Vice Chancellor, FATA University, welcomed the participants and appreciated their presence. He underlined the importance of the agenda items and apprised the Forum of the administrative, financial, infrastructural, and overall developmental progress of the University.

In this context, the Vice Chancellor specifically informed the forum of recent developments at the University, including the induction of a new bus into the University's transport fleet, which is expected to facilitate students commuting to the campus. He further apprised the forum of the collaboration with the District Sports Department Kohat and Dostan Coal Company for the organization of Sports Week at the University, wherein the collaborating organizations sponsored the event and extended scholarships to deserving and needy students.

The Chair also apprised the House of various challenges being faced by the University, particularly the acute shortage of water. He informed that the University presently has four tube wells, out of which only one is partially operational for approximately twenty minutes and supplies turbid water. Consequently, the University is compelled to deploy water tankers throughout the day to fulfill the water requirements of the campus residents and hostels. The Chair further informed that the matter has been taken up with all relevant authorities and that, through the personal interest of the Commissioner, Kohat Division, and the cooperation of the Kohat Division Developmental Project (KDDP) and the local community, who have offered land for the installation of a tube well, the University is likely to receive water through a piped supply system at no financial cost to the University. This initiative is expected to address one of the major challenges faced by the University. He further informed the House that the University is also in consultation with local coal miners to finance further deepening of the existing tube wells on campus to augment the water supply.

The Vice Chancellor further informed the House that the University is in the process of executing a Memorandum of Understanding (MoU) with the Khyber Pakhtunkhwa Education Endowment Fund (KPEEF) for the provision of scholarships to the students at the University. He also expressed his gratitude to the forum for its cooperation in the expeditious filling of the vacant positions of Treasurer and Controller of Examinations, which has contributed towards strengthening the institutional capacity of the University.

The forum appreciated the resolve, commitment, and capacity of the University management, commended their tireless efforts, and assured its full support in all possible matters pertaining to the progress and development of FATA University.

The forum further expressed its appreciation for the support extended by the Commissioner, Kohat Division, and the KDDP, and directed that letter of appreciation be issued to the Commissioner, Kohat Division, and the KDDP accordingly.

Subsequently, the agenda items were taken up sequentially, discussed in detail, and decisions were recorded as under:

Agenda Item No. 01**CONFIRMATION OF THE MINUTES OF THE 25th AND 26th MEETING OF THE SYNDICATE HELD ON 13/09/2025 AND 11/12/2025, RESPECTIVELY, AND COMPLIANCE REPORT ON THE DECISIONS TAKEN THEREIN****The Matter:**

The Chair presented the minutes of the 25th and 26th Meeting of the Syndicate held on 13/09/2025 and 11/12/2025, for perusal and confirmation. The reports on the action taken on the decisions of 25th and 26th were presented to the house for information.

Discussion:

The Chair referred to Agenda Item No. 3 of the 25th meeting of the Syndicate, wherein house rent allowance was approved as per the entitlement of a BPS-22 officer at Darra Adam Khel. He informed the House that he wished to surrender the said offer of house rent allowance, considering that the approved amount would be insufficient to secure suitable accommodation even at Darra Adam Khel. He further stated that, despite the prevailing security situation in the area, he is willing to reside temporarily in the University Guest House, which would also facilitate enhanced on-campus presence, supervision, and academic and administrative engagement.


The Nominee of the Higher Education Department (HED) stated that the Vice Chancellor is entitled to a fixed salary along with prescribed perks and privileges, wherein provision of accommodation falls under the said perks and privileges. He further sought the views of the Nominee of the Finance Department, who explained that in cases where government accommodation is not available, house rent allowance is paid; however, such allowance is generally not commensurate with prevailing market rental rates.

Dr. Maqsood Haider who also look after the matters of the office of the Deputy Director Administration in additional capacity, apprised the forum that, in consultation with the relevant security agencies, it was assessed that the residence of the Vice Chancellor on campus would pose a significant security risk, and therefore such an arrangement is not advisable.

Prof. Dr. Qibla Ayaz emphasized that, keeping in view past precedents and the prevailing security situation in the area, he is not in favor of the Vice Chancellor residing on campus. He stated that, in the event of any untoward incident, it would constitute a serious loss and embarrassment for the province and country. He suggested that, notwithstanding existing rules and procedures, the matter should be considered with a broader and pragmatic perspective. He further stated that there is no BPS-22 officer stationed at Darra Adam Khel and cited examples of couple of cases where the houses in Peshawar are declared as Vice Chancellor's houses.

In response, the Nominee of HED clarified that the said cases are still under process and pending approval by the Chancellor of Public Sector Universities, and that, in those instances, official residences already existed at the campus of their parent University. He further stated that, in the present case, the University would be required to rent a house and designate it as the Vice Chancellor's residence.

Prof. Dr. Qibla Ayaz, in response, stated that if a residence at the other University could be declared as a Vice Chancellor's House, then a similar arrangement could also be made in Peshawar for FATA University, subject to the availability of an appropriate legal and financial provision. Thereafter, the Nominee of HED proposed that a committee be constituted to examine the matter.

comprehensively and make recommendations regarding the provision of accommodation for the Vice Chancellor. The Forum unanimously agreed to the proposal.

Decision:

The Forum unanimously confirmed the minutes and expressed satisfaction over the Action Taken Report of the 25th and 26th meetings of the Syndicate. However, with regard to Item No. 3 concerning the accommodation of the Vice Chancellor, the Forum approved the constitution of the following committee to examine the matter and submit its recommendations to the Syndicate:

Agenda Item No. 02 APPROVAL OF THE MINUTES OF THE 2ND MEETING OF THE AFFILIATION COMMITTEE

The Matter:

The Chair briefed the house that the 2nd Meeting of the affiliation committee was held on 31/12/2025 and minutes are presented before the house, for perusal and confirmation.

Discussion:


The Nominees of HEC raised an objection regarding the issuance of a No Objection Certificate (NOC) to GCMS College for affiliation with a university in the Swat Division and highlighted that, in accordance with the HEC Affiliation Policy, if a program is not available in a university and in case where the Act does not specify a definite jurisdiction, affiliation may only be granted by the university located in the relevant division. If no university exists in that division, the affiliation may be granted by a university in an adjoining division, or, if none is available, by any public sector university located in the provincial capital.

In response, the Director HED clarified that the matter pertained to a special government initiative, under which certain commerce colleges across the province are being converted into technical colleges for the offering of technical programs and the University of Engineering and Applied Sciences, Swat, has been designated by the Government to grant affiliation to these colleges.

The principal referred to a letter issued by the Directorate regarding the conversion of certain BS programs into associate degree (AD) programs, wherein it was requested that such programs may be allowed without undergoing an additional affiliation process. He also referred to another letter stating that, for such cases, the additional inspection fee shall be waived. The Nominee of HEC inquired about the academic hierarchy of BS and AD programs. In response, the Chair clarified that BS programs require more stringent academic, faculty, and infrastructural requirements for affiliation as compared to AD programs. Thereafter, the nominee of HEC proposed that if a college is converted from a BS program to an AD program, affiliation may be granted without conducting a fresh inspection, as the BS program constitutes a higher academic qualification. This view was endorsed by the Director, HED, who stated that other public sector universities are also implementing the said directives by granting affiliation without an additional process. The Chair further clarified that the matter relating to the waiver of inspection fees, as requested in the relevant letter, falls within the purview of the Finance and Planning Committee (F & PC) and shall, therefore, be routed through the said forum for consideration and approval.

Decision:

The House approved the recommendations of the 2nd meeting of the Affiliation Committee, with the following amendment to Agenda Item No. 7:

In cases where a BS program has been converted into an AD program, no inspection visit by an inspection committee shall be required, and the case shall be placed directly before the relevant statutory forum for consideration and grant of affiliation.

The House further endorsed the recommendations of the Affiliation Committee regarding the fee waiver letter, with the direction that the matter be routed through the Finance and Planning Committee for its recommendations.

**Agenda Item No. 03 WILLFULL ABSENCE OF DR BILAL JAN,
ASSISTANT PROFESSOR, DEPARTMENT OF
COMPUTER SCIENCE**

The Matter:

The Chair briefed the house that Dr. Bilal Jan, Assistant Professor, appointed in the 3rd meeting of the Syndicate held on 13.03.2019 and was also serving as head Department of Computer Science, was granted NOC and Privilege Leave from 03.08.2025 to 22.08.2025 for delivering seminar. After expiry of the approved leave, he failed to resume duty and instead requested additional leave for Fall 2025, which was regretted due to faculty shortage, particularly in view of the conditional NOC issued by the HEC Accreditation Team.

The forum was further apprised that despite repeated directions to resume duty, Dr. Bilal Jan did not join the University and is reportedly employed elsewhere, causing serious academic difficulties. His continued absence without approval attracts disciplinary action under the Efficiency and Discipline Statutes, 2016 of the University of Peshawar.

Discussion:

Prof. Dr. Qibla Ayaz inquired whether Dr. Bilal Jan is a regular/confirmed employee of the University, to which the Chair replied that he is a regular/confirmed employee.

The Nominees of the Higher Education Department and the Establishment Department emphasized that cases of willful absence from duty must be dealt with in accordance with the statutory framework to safeguard the academic and administrative functions of the University. The Nominee of the Finance Department highlighted the need to maintain adequate faculty strength to prevent disruption of departmental operations.

The Nominee of the Establishment Department sought clarification regarding official correspondence with Dr. Bilal Jan. The Chair placed on record relevant email correspondence, including the rejection of the leave extension request and repeated directions to resume duty.

The Nominee of the Establishment Department further advised that, in cases of willful absence, the procedure provides that formal inquiry may be dispensed with, and the employee be issued a notice directing resumption of duty within seven (07) days. In case of non-compliance, a public notice shall be published in two national newspapers, allowing ten (10) days for resumption of duty, failing which disciplinary action may be taken.

The Nominee of HEC inquired about the procedure if Dr. Bilal Jan subsequently resumes duty. The Nominee of Establishment Department explained that, if he resumes service, a disciplinary inquiry would be initiated as per statutory procedure.

Decision:

After detail deliberations, the forum decided that the following procedure shall be adopted in case of willful absence under the Employees (Efficiency & Discipline) Statutes, 2016:

1. A notice shall be issued to the accused through registered post with acknowledgment due at his home address, directing him to resume duty within fifteen (15) days from the date of issuance of the notice.
2. If the same is received back as undelivered or no response is received within stipulated time, a notice shall publish in at least two leading newspapers, directing him to resume duty within fifteen (15) days from the date of publication.
3. If he still fails to comply, an ex-parte decision shall be taken by the competent authority (Syndicate FATA University) against him. Upon expiry of the stipulated period mentioned in the notice, a major penalty of "Removal from Service" may be imposed by the competent authority i.e., Syndicate FATA University.
4. In case Dr. Bilal Jan resumes duty, a case for formal inquiry shall be placed before the Syndicate FATA University by preparing a proper Charge Sheet & Statement of Allegations for signature of the Syndicate FATA University as per Statutes referred to above.

Agenda Item No. 04 APPROVAL OF THE ACR/PER FORMAT FOR FATA UNIVERSITY EMPLOYEES

The Matter:

The chair apprised the house that FATA University currently lacks a standardized Annual Confidential Report (ACR) / Performance Evaluation Report (PER) format for its employees, which limits objective assessment for promotion, confirmation, and other official recommendations. The proposed ACR/PER formats were placed before the Syndicate for consideration and approval.

Discussion:

The Nominee of the Establishment Department observed that the proposed formats prescribe a single format for employees in BPS-1 to 16, whereas separate formats should be used for each cadre according to their scope of work, as prescribed by the Government of Khyber Pakhtunkhwa. He provided the relevant formats to the house for perusal and recommendation, which was supported by the Nominee of HED for use in performance evaluation.

The Nominee of the Finance Department stated that most existing ACRs are outdated and recommended that the University take advantage of its autonomy to develop a digital ACR system, integrated in CMS System, based on monthly or quarterly entries, and compiled at year-end. The Chair responded that the current CMS system can accommodate only the Resource and Learning Management modules, but expressed hope that a digital ACR module can be integrated within the next six months. Meanwhile, he requested a stop-gap arrangement to ensure continuity of performance evaluations.

Decision:

The Syndicate decided that, as a stop-gap arrangement, the ACR/PER formats provided by the Nominee of the Establishment Department shall be used for performance evaluation, with the

condition that a digital ACR/PER proformas integrated in CMS of the University shall be developed and presented before the forum for approval and subsequent implementation within the next six months.

Agenda Item No. 05 APPROVAL OF THE MINUTES OF THE 3RD AND 4TH MEETINGS OF THE INSTITUTIONAL QUALITY CIRCLE (IQC) HELD ON 26/11/2025 AND 21/12/2025, RESPECTIVELY.

The Matter:

The Chair briefed the house that the 3rd and 4th meetings of the Institutional Quality Circle held on 26/11/2025 and 21/12/2025. The recommendations of the meetings are now placed before the house for consideration and confirmation.

Decision:

The Syndicate unanimously approved the Minutes of the 3rd and 4th meetings of the Institutional Quality Circle (IQC).

Agenda Item No. 06 APPROVAL OF THE RECOMMENDATIONS OF THE NEED ASSESSMENT COMMITTEE FOR PROPOSED HIRING OF FACULTY AND ADMINISTRATIVE POSITIONS

The Matter:

The Syndicate was apprised that the Higher Education, Archives & Libraries Department, Government of Khyber Pakhtunkhwa, has directed that issuance of NOC for faculty and administrative positions requires a detailed Needs Assessment Report, subsequently approved by the Syndicate, for positions in BPS-16 and above. In compliance, the Needs Assessment Committee held meetings on 4-5 November 2025, and its minutes, recommending the faculty and administrative positions, are submitted to the house for consideration and approval.

Discussion:

The Nominee of the HED appreciated the recommendations of the Needs Assessment Committee and observed that the proposals reflect a prudent and realistic approach by the University in determining only the essential minimum strength required for the smooth functioning of its academic and administrative affairs, thereby avoiding any undue financial burden. He, however, emphasized that, for processing of the NOC, the requisite data must be submitted in the prescribed departmental format.

Decision:

The Syndicate approved the recommendations of the Needs Assessment Committee.

The Matter:

The forum was apprised that, under the Khyber Pakhtunkhwa Universities Act, 2012, the Vice-Chancellor is authorized to appoint subject experts for the evaluation of candidates from a panel recommended by the Syndicate. The proposed panel of experts are placed before the Syndicate for consideration and approval.

Decision:

The House approved the list of subject experts for the disciplines of education, psychology, electronics and microbiology.

Agenda Item No. 08 FATA UNIVERSITY DRAFT STATUTES-2025

The Matter:

The Chair apprised the Forum that FATA University, established in 2013 under the FATA University Regulation, 2013, commenced its first academic session in 2016 but has not yet framed its own Statutes. Previously, the Syndicate had adopted the Statutes of the University of Peshawar as an interim measure. Subsequently, the Vice-Chancellor reconstituted a committee for framing the Statutes, Rules, and Regulations of FATA University, which, after a series of meetings, prepared the Draft Statutes of FATA University, which were presented to the 25th Syndicate. The Syndicate then constituted a sub-Committee to evaluate the Draft Statutes and submit its recommendations. The Draft Statutes, along with the sub-Committee's recommendations, are now placed before the Syndicate for consideration and onward submission to the Senate.

Recommendation:


The Syndicate recommended the Draft Statutes to the Senate for approval and further recommended that, where feasible, the Draft Statutes be processed through HED for onward submission to the Senate, after first being placed before the Standing Committee of the Senate, so as to ensure their presentation to the Senate in a clear and well-considered manner. It was also recommended that the Draft Statutes be circulated to the members of the Senate well in advance to enable them to review the same prior to the Senate meeting.

**Agenda Item No. 09 THIRD-PARTY AUDIT REPORT 2022-23, 2023-24 AND
2024-25**

The Matter:

The Syndicate was apprised that, under Section 38(6) of the Khyber Pakhtunkhwa Universities Act, 2012 (as amended), the University is required to conduct a yearly Third-Party Audit. In compliance, a Third-Party Audit of FATA University for the subject period was conducted by RSM Avais Hyder Chartered Accountants. The Audit Report, containing observations and recommendations, was placed before the Syndicate for information and is to be reported to the Senate as required.

Agenda Item No. 10 RECOMMENDATIONS ON REQUEST FOR CONCESSION IN CAFETERIA AND SHOP RENT

The Matter:

The Chair briefed the house that the University had issued a tender for the allotment of the cafeteria and shops on campus. Following the prescribed procedure, the designated spaces were allotted to the highest bidders, and rent agreements were executed. Subsequently, the cafeteria and shop owners requested concessions in rent, citing lower-than-anticipated student enrollment, operational losses, and discrepancies between the tendered rates and the C&W Highway Sub-Division, Kohat assessed rates. The Director of Administration also submitted a report highlighting the discrepancies in rent assessment.

Decision:
The House constituted the following committee to make its recommendations after details assessment.

Table Agenda No. 1 GUIDANCE ON THE REQUEST TO PROVIDE ELECTRICITY TO THE SECURITY FORCE DEPLOYMENT ADJACENT TO UNIVERSITY.

The Matter:

The Chair apprised the house that the 23rd meeting of the Syndicate held on 24/01/2025, on the request of the Assistant Commissioner, Darra Adam Khel, regarding provision of electricity to Vice Chancellor

the security force deployment adjacent to university, directed that a letter be issued to the Chief Executive Officer, TESCO, for provision of a separate electricity connection to the said deployment to ensure smooth functioning of its operations, as it was burdensome for FATA University, being at a nascent stage, to bear substantial electricity charges.

The chair further briefs the house that recently, due to the energization of separate transformers installed for each University building, the electricity supply to the deployment was discontinued owing to the non-functioning of the previously installed single transformer. Thereafter, officials of the Wing/Security Force started visiting the University premises and insisting upon restoration of electricity supply, without honoring the earlier Syndicate earlier decision.

The Chair further stated that, owing to the sensitive and prestigious nature of their duties, it is the responsibility of every organization to extend facilitation to such deployments. However, it was pointed out that FATA University has solarized the campus with the expectation of reducing electricity expenditure through limited reliance on grid supply. Accordingly, a budgetary provision of Rs. 8.00 million under the electricity head for the financial year 2025-26 was approved by the Senate. Despite this, electricity bills amounting to Rs. 8.47 million were incurred within the first two quarters of the financial year, thereby exhausting the allocated budget.

Discussion:

The Chair informed the house that, following a recent visit by the concerned officials, a letter was issued requesting them to provide details of their electricity load. The Nominee of the HED inquired about the response to the said letter and was informed that no reply had been received so far. He recommends that the University should wait for the load details, after which the matter may be taken up with TESCO.

Prof. Dr. Qibla Ayaz, while appreciating the services rendered for national security, emphasized that alternative arrangements should be explored by the concerned deployment in case grid electricity is not available. He further stated that FATA University is not the relevant authority in this matter and that the issue should be pursued directly with TESCO.

The Nominee of HEC observed that, in view of the University's limited budgetary position, it is not feasible for FATA University to provide electricity while not deciding about specific terms and conditions for the same. The Principal, Government Degree College, Darra Adam Khel, informed the house that a new commercial electricity extension exists in the area, which could also be utilized by the deployment.

Decision:

After detailed deliberation and sympathetic consideration, keeping in view the sensitive nature of the duties of the concerned deployment, as well as the University budgetary constraints and audit observations, the Syndicate decided that, as an interim arrangement, electricity may be provided subject to the submission of load calculations, installation of check meters, and provision of circuit breakers strictly in accordance with the approved load. This arrangement shall further be subject to a written assurance for payment of electricity bills strictly based on actual units consumed and shall remain valid only up to 31st March 2026. During this interim period, the authorities concerned shall make arrangements for a permanent solution. The syndicate further directed to communicate in writing the decision of the syndicate with copy to their higher authorities as well.


